Information We Collect

We may collect personal information that you voluntarily provide, including but not limited to:

- Name
- Email address
- Phone number
- Mailing address
- Emergency contact information (for events or programs)
- Demographic or participation-related information relevant to ministry activities

This information is typically collected when you:

- Register for church events or classes
- Sign up for small groups, ministries, or volunteer opportunities
- Submit prayer requests or contact forms
- Subscribe to church communications
- Make donations (through secure third-party processors)

How We Use Your Information

All information collected is used solely for the purpose for which it was provided, including:

- Event registration and attendance tracking
- Group or ministry participation
- Internal communication related to church activities
- Pastoral care and ministry coordination
- Administrative and record-keeping purposes

Grace Bible Fellowship does not sell, rent, or trade personal information. Your data will not be used outside of the church's legitimate ministry and administrative needs related to the original reason it was collected.

These providers are permitted to access personal information only as necessary to perform services on our behalf and are expected to maintain appropriate confidentiality and security standards.

Online donations are processed through secure, PCI-compliant third-party platforms. GBF does not store credit card or banking information on its servers.

Cookies and Website Analytics

Our website may use cookies or similar technologies to improve functionality and user experience. These may collect non-personally identifiable information such as browser type, pages visited, or time spent on the site.

You may choose to disable cookies through your browser settings; however, some website features may not function properly.

Data Security

We take reasonable administrative, technical, and physical measures to protect personal information from unauthorized access, disclosure, alteration, or destruction. While no method of transmission over the internet is completely secure, we strive to use commercially acceptable means to protect your information.

Children's Privacy
